The undersigned, being duly sworn, upon his oath, complains and says that on or about the 2<sup>nd</sup> day of November, 2015 in Colfax County, New Mexico, the above named defendant did:

# COUNT 1: CONSPIRACY TO SHOOTING AT INHABITED DWELLING OR OCCUPIED BUILDING (RESULTING IN GREAT BODILY HARM) 0080

did knowingly combine with another for the purpose of committing a felony, to wit: [Shooting at Inhabited Dwelling or Occupied Building (Resulting in Great Bodily Harm to the victim Michael Garcia)] within or without this state, contrary to NMSA 1978, §§ 30-28-02 & [§30-03-08(A).]. (a [2nd degree felony] a 3rd degree felony).

### COUNT 2: CONSPIRACY TO SHOOTING AT INHABITED DWELLING OR OCCUPIED BUILDING (RESULTING IN GREAT BODILY HARM) 0080

### COUNT 1: SHOOTING AT INHABITED DWELLING OR OCCUPIED BUILDING (RESULTING IN GREAT BODILY HARM) 0080

did willfully discharge a firearm at an inhabited dwelling house or occupied building or motor vehicle which resulted in great bodily harm to [Michael Garcia], contrary to NMSA 1978, § 30-03-08(A). (a 2nd degree felony).

### COUNT 2: SHOOTING AT INHABITED DWELLING OR OCCUPIED BUILDING (RESULTING IN GREAT BODILY HARM) 0080

did willfully discharge a firearm at an inhabited dwelling house or occupied building or motor vehicle which resulted in great bodily harm to [Miguel Rodriguez], contrary to NMSA 1978, § 30-03-08(A). (a 2nd degree felony).

### COUNT 3: ASSAULT WITH INTENT TO COMMIT A VIOLENT FELONY (WITH INTENT TO COMMIT MURDER) 0067

the above-named defendant did assault [Hugo Arreola] with the intent to commit murder, contrary to NMSA 1978, § 30-03-03. (a 3<sup>rd</sup> degree felony).

### COUNT 4: AGGRAVATED BATTERY (USE OF DEADLY WEAPON) 0070

### COUNT 6: ASSAULT WITH INTENT TO COMMIT A VIOLENT FELONY (WITH INTENT TO COMMIT MAYHEM) 0067

the above-named defendant did assault [Hugo Arreola] with the intent to commit mayhem, contrary to NMSA 1978, § 30-03-03. (a 3<sup>rd</sup> degree felony).
