



**RESOLUTION NO. 2017-49**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF RATON, NEW MEXICO ESTABLISHING AND DIRECTING RATES AND FEES FOR MANAGEMENT OF CERTAIN WASTE MATERIALS**

**WHEREAS**, the City of Raton owns, operates, constructs and maintains a municipal solid waste system for the collection, management and disposal of Municipal Solid Waste (MSW) and other types of restricted waste, refuse and recyclable material; and

**WHEREAS**, it is essential to the public health, welfare and safety to provide adequate funding to meet the capital, operational and maintenance requirements of the municipal solid waste system; and

**WHEREAS**, the Raton City Commission did adopt Ordinance No. 996 on October 24, 2017 providing for the establishment of fees for management of non-MSW wastes and restricted wastes; and

**WHEREAS**, the City of Raton has reviewed waste disposal methods, requirements, demands and costs and other such information as necessary to ensure that rates adopted herein are fair and equitable to Raton citizens, businesses and solid waste system ratepayers; and

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF RATON:** that rates, fees and charges are adopted and approved as detailed herein.

**Tire Disposal Fees**

Passenger Vehicle Tires up to 20 inches	\$ 5.00 Per Tire	\$ 8.00 Per Tire
Commercial Truck Tires up to 24.5 inches	\$ 12.00 Per Tire	\$ 20.00 Per Tire

\* Applies to existing City of Raton Solid Waste account in good standing

Fees shall not include collection, tires must be delivered to designated City of Raton Transfer Facility

Fees shall be doubled for tires mounted on rims/ wheels.

Tractor and heavy equipment tires shall not be accepted.

**Construction and Demolition Waste Fees**

Clean Lumber (no painted, glued or treated wood)	No Fee	\$ 25.00 Per Ton

Comingled lumber and other waste shall be considered C&D waste and appropriate fees shall be applied.

Persons with an existing residential solid waste account in good standing with the City may dispose of one (1) ton of C&D waste per year at no charge or fee if waste originates from a residential project located within the municipal boundaries.
